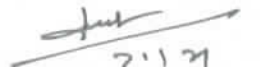

In exercise of the powers conferred under proviso to Article-309 of the Constitution on India, The Governor of Bihar is pleased to make the following Rules to amend the Bihar, Road Construction Department Amin Cadre (Field Establishment) (Recruitment and Service Conditions) Rules, 2017 to field offices (circle) under the Road Construction Department of State of Bihar :-

1. **Short title, extent and commencement.-** (1) These Rules may be called "The Bihar Road Construction Department Amin Cadre (Field Establishment) (Recruitment and Service Conditions)(Amendment) Rules, 2020".
(2) It shall extend to whole of the State of Bihar.
(3) It shall come into force at once.
2. **Substitution of sub-rule-(vi) of Rule-2 of the Bihar, Road Construction Department Amin Cadre (Field Establishment) (Recruitment and Service Conditions) Rules, 2017 .-** Sub-rule-(vi) of Rule-2 of the said Rules, 2017 shall be substituted by the following :-

"(vi) Examination Authority means the Bihar Staff Selection Commissioner, Bihar Combined Entrance Competitive Examination Board (BCECEB) or any other authority selected by the Road Construction Department".

3. Substitution in sub rule (1) of Rule-6 of the Bihar, Road Construction Department Amin Cadre (Field Establishment) (Recruitment and Service Conditions) Rules, 2017.- Sub rule (1) of Rule-6 of the said Rules, 2017 shall be substituted by the following :-

"(1)- Direct appointment to the post of Amins will be made on the basis of recommendation obtained as per the result declared in the examination conducted for the posts of amin by the examinations Authority adding the obtained marks and marks determined for the experience".

4. After sub rule-(1) in Rule-6 of the Bihar, Road Construction Department Amin Cadre (Field Establishment) (Recruitment and Service Conditions) Rules, 2017 .- The following new sub rule-(1)(A) shall be added after sub rule (1) of Rule 6 of the said Rules, 2017 :-

"(1) (A) Separate requisitions of the all related Superintending Engineer, Road Construction Department, Bihar will be sent through the Department to the Examination Authority authorized for conducting examination and recommendations of the Examination Authority shall also be received separately".

5. After sub rule-(2) in Rule-6 of the Bihar, Road Construction Department Amin Cadre (Field Establishment) (Recruitment and Service Conditions) Rules, 2017 .-The following new sub rule-(3) shall be added after sub rule (2) of Rule 6 of the said Rules, 2017 :-

"(4) Applications received from candidates for direct appointment to the post of Amin shall be short-listed on the basis of marks obtained in the Intermediate or equivalent to Intermediate exam and experience obtained by Amins working under State Government on the basis of their experience, which will not be less than ten times of the total vacancy".

6. Substitutions of Rule-7 of the Bihar, Road Construction Department Amin Cadre (Field Establishment) (Recruitment and Service Conditions) Rules, 2017 .- Rule-7 of the said Rules shall be substituted by the following :-

"7- Syllabus for the written Competitive Examination :- Competitive Examination of 75 marks will be held by the Examination Authority authorized for the selection to the post of Amin. There shall be one question paper having two parts in the Competitive Examination as follows :-

- (i) First Part-1 General Knowledge, Current Affairs, General Science and General Hindi-50 marks.
- (ii) Second Part-2 General Maths-25 marks".

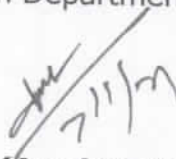
