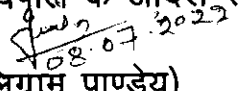

No-7/Astha.-04-16/2019GAD ..1.1.50.4...../In exercise of the powers conferred by Section 23 read with Sections 4, 5 and 6 of the Family Courts Act, 1984 (Central Act No. 66 of 1984), the Governor of Bihar, in consultation with the Patna High Court, Patna is hereby pleased to make the following Rules to amend the Bihar Family Court Rules, 2011:-

The Bihar Family Court (Amendment) Rules, 2022

1. Short title and commencement.-

(1) This Rules may be called the Bihar Family Court (Amendment) Rules, 2022.

(2) It shall extend to the whole of the state of Bihar.

(2) It shall come into force on the date of its publication in the Official Gazette.

2. Substitution of Rule 9(3) of the Bihar Family Court Rules, 2011.-
Existing Rule 9(3) shall be substituted by as here under:-

“The Court may appoint two Counsellors from the list of authorized persons notified under sub-rule (1).”

3. **Substitution of Rule 9(6) of the Bihar Family Court Rules, 2011.-**
Existing Rule 9(6) shall be substituted by as here under:-

"A Counsellor or a person associated under sub-rule (3) may be paid a sum of Rs. 1500/- (One thousand Five hundred only) per case only as honorarium by the State Government at appropriate stage to be decided by the Principal Judge in his own discretion but in any case before passing of the Judgment. Such honorarium shall be revisable from time to time and at least after every five years."
