In exercise of the power conferred under proviso to Article- 309 of the constitution of India, The Governor of Bihar is pleased to make the following Rules to amend "Bihar Local Area Engineering Service Rule, 2016"

1. Short title, extent and Commencement :

- (1) These Rules may be called "Bihar Local Area Engineering Service (Amendment) Rule, 2024"
- (2) It shall extend to the whole to the Sate of Bihar.
- (3) It shall come into force with immediate effect.

2. Substitution of Rule-10 of Bihar Local Area Engineering Service Rules, 2016.

Rule-10 of the said rules shall be Substituted by the following:-

"A person shall be declared probationary from the date of joining (appointment) to the post of Assistant Engineer. The period of probation shall be of 01 (one) year. If the service is not satisfactory during the probation period, it may be extended for 01 (one) more year. If the service is not satisfactory even during the extended period, the service may be terminated."

3. Substitution of Rule 11 (i) of "Bihar Local Area Engineering Service Rule, 2016"

The Rule 11 (i) of the said Rules shall be substituted by the following:-

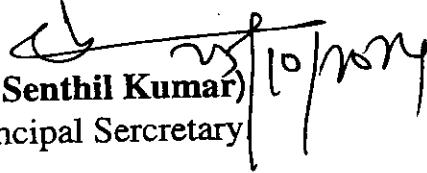
"If a government servant appointed through direct recruitment does not pass the relevant departmental examination conducted by the Board of Revenue within One year from the date of joining the post, he will not be given further increment until he passes the examination."

4. Substitution of Rule 12 of "Bihar Local Area Engineering Service Rule, 2016"

The Rule 12 of the said Rules shall be substituted by the following:-

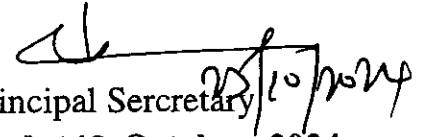
" The subject, syllabus and procedure of the departmental exam will be regulated by Board of Revenue, Bihar, Patna. "
